2007 Three countries (China, Japan and Korea) **Accounting Standard Setters Meeting**

The China Accounting Standards Committee (CASC), the Accounting Standards Board of Japan (ASBJ) and the Korea Accounting Standards Board (KASB) held the 2007 three countries Accounting Standard Setters Meeting at Royal Park Hotel in Tokyo, Japan for two days on 28 and 29 November 2007.

This year's Meeting also had representatives of the International Accounting Standards Board (IASB) as special invitees and delegates of the Hong Kong Institute of Certified Public Accountants and Macao Committee for Registry of Auditors and Accountants as observers (see Appendix for a detailed list of participants).

The CASC, ASBJ, and KASB presented updates on recent developments in their national accounting standards and on their policy and efforts toward global convergence of accounting standards and the IASB presented update on recent development in its accounting standards.

In addition, the CASC, ASBJ, and KASB discussed future direction for the three countries meeting. They agreed that they should continue this regular meeting and pursue more productivity, while recognizing that there are some differences in their convergence processes.

The 2008 three countries Accounting Standard Setters Meeting will be hosted by the CASC.
